All Nursing Program applicants must submit the <u>Nursing Admission Checklist</u> form <u>online</u> in <u>addition to the Fall</u> **2026 STCC online Application for Admissions.** 

Preference is that the Fall 2026 STCC online Application for Admissions, with Nursing selected as the desired degree, be completed and submitted prior to the checklist.

The checklist must be completed all in one session. You will NOT be able to save the checklist once started. If you leave, all data and information you entered will be lost, and you will need to start again. AFTER SUBMITTING THE CHECKLIST, YOU WILL RECEIVE AN EMAIL CONFIRMATION. IF YOU DO NOT RECEIVE AN EMAIL AFTER SEVERAL MINUTES, AND YOU HAVE CHECKED YOUR SPAM FOLDER, CONTACT THE ADMISSIONS OFFICE at admissions@stcc.edu.

# COMPLETION OF ADMISSION PREREQUISITES- THE FOLLOWING MUST BE COMPLETED IN ORDER TO APPLY TO THE NURSING PROGRAM. YOU WILL BE ASKED IF THESE REQUIREMENTS HAVE BEEN COMPLETED:

- APPLICATION: Fall 2026 online Application for Admissions, with Nursing selected as the desired degree, submitted to the STCC Admissions Office.
- MATH REQUIREMENT: Completion of one of the following within the past 5 years 3 months\* (For Fall 2026 Admission, must have been taken no earlier than the Spring Semester of 2021):
  - Algebra 2 (grade 80 or higher), or its equivalent, at a high school or accredited college (STCC MAT063 or MAT097) OR
  - Placement at the college-math level on the STCC placement exam (Accuplacer MAT101 or ALEKS 100p) (Being waived from taking the STCC math placement exam due to high school GPA DOES NOT meet the Nursing Program math requirement) **OR**
  - o College level (100 or higher) math course with a grade of 77 or higher

\*If the applicant met the minimum grade requirement for the math course, but the course was taken prior to the Spring Semester of 2021, the outdated math course will be accepted if the applicant has obtained the TEAS math subtest benchmark score of 69.

TEAS TEST: You will be asked to provide the highest math, science, English and reading subtest scores you received within the last three years on the Test of Essential Academic Skills, Version 6 or Version 7.
 Documentation of results should be uploaded to the checklist, emailed to admissions@stcc.edu, uploaded directly to your online application, or a hard copy can be submitted to the Admissions Office. (Please note: If the TEAS were taken through the Authorized Testing Center at STCC, then a copy of your scores will be automatically submitted by ATI, the testing agency, to the Nursing Department during the first week of February.)

You may obtain a copy of your TEAS score report at <a href="www.atitesting.com/login">www.atitesting.com/login</a>. After logging in, you will need to select the MY RESULTS tab. Then scroll down and select the TEAS assessment that you would like to obtain a score report for. Please be sure the score report includes subtest scores. TEAS scores must have been taken within three years of the February 1 application deadline. For the Fall 2026 application cycle, TEAS scores must have been taken February 1, 2023 or later.

OFFICIAL TRANSCRIPT(S): Submission of an official transcript from ALL colleges or universities where you
have completed academic coursework, including high school, to the STCC Admissions Office. Transcripts
need to be received by February 1 in order for your application to be complete. (Note: For in progress courses
it is best to wait until final grades appear on your transcript before requesting that the transcript be sent to the
STCC Admissions Office. YOU DO NOT NEED TO SUBMIT A TRANSCRIPT FOR COURSEWORK TAKEN
AT STCC.)

Be sure to UPLOAD THE DIRECT AND INDIRECT PATIENT CARE EMPLOYMENT VERIFICATION FORM TO THE CHECKLIST OR SUBMIT TO THE FORM TO THE ADMISSIONS OFFICE BY FEBRUARY 1. The form

can be emailed to <a href="maileo:admissions@stcc.edu">admissions@stcc.edu</a>, uploaded directly to your online application, or a hard copy can be submitted to the Admissions Office.

You will be asked to list any <u>healthcare</u> certifications you hold. Please note: You DO NOT need to upload proof of certifications to the checklist, or provide documentation to the Admissions Office.

## **MEDICAL RECORDS:**

You will be asked about your ability to provide vaccination/immunity records. Upon acceptance into the Nursing Program you will need to provide proof of the following: Hepatitis B vaccines AND titer showing immunity, 2 MMR and 2 Varicella vaccines, COVID-19 vaccination, and a current TDaP. Proof of hepatitis B immunity has been a problematic requirement for students to complete on time. On the checklist, you will specifically be asked about your ability to provide a hepatitis B surface antibody lab results report. If you do not have a hepatitis B surface antibody report showing a "positive" or "reactive" result, you will want to have your provider order one immediately. The protocol for revaccination can be lengthy. Accepted students who are not compliant may not be eligible to continue in the program. Contact compliance@stcc.edu with questions.

## **GOOD MORAL CHARACTER:**

The Massachusetts Board of Registration requires compliance with the Good Moral Character Policy. Non-compliance with this policy can prevent individuals from getting a nursing license. You will be asked to acknowledge that you have read and understand the Good Moral Character (GMC) and Licensure Policy.
