#### I. Call to Order & Roll Call

Acting Chair Jynai McDonald called the meeting to order at 5:02 p.m.

The following Trustees were present at roll call: Acting Chair Jynai McDonald, Trustee Secretary Elizabeth Oleksak-Sposito, Student Trustee Zoya Plunkett-Brown, Alumni Trustee Laurie Martin, Trustee Jeff Sattler, and Trustee MacArthur Starks. Six Trustees present, constituting a quorum. Trustee Samalid Hogan joined at 5:10 p.m.

# II. Approval of Minutes

## b) Board of Trustee Meeting - Monday, September 25, 2023

Trustee Jeff Sattler moved to approve the minutes from the September 25<sup>th</sup> Board of Trustees meeting, seconded by Trustee MacArthur Starks. After no further discussion, unanimously approved.

## III. President's Perspective – Dr. John B. Cook, President

b) Fall Semester Outlook (Final Enrollment at November meeting)
Fall 1 and Fall2 numbers will be compiled and ready for the November 27<sup>th</sup> full Board meeting, along with updated data for MassReconnect.





#### c) Fall II: Extended Tuesday Evening Operations

As a test, student services, including the library are extending hours of operation on Tuesdays to support students enrolled in evening courses. Tuesday is the day when more evening courses are offered.

d) October Legislative Delegation Breakfast

Shared in the packet is program from the October 13<sup>th</sup> Regional Legislative Delegation Forum/Breakfast. Question asked as to how members can continue to be helpful to STCC.

e) New UMass Amherst Chancellor

Dr. Cook recently met with the new UMass Amherst Chancellor, Dr. Javier Reyes. Included as part of the conversation was the value of having UMass in Springfield.

**f**) Mason Square/Mass Development TDI (Transformative Development Initiative)

The Mason Square/Mass Development Transformative Development Initiative (TDI) was discussed, including the participation by STCC (efforts of contributing to our area ecosystem, and ongoing collaboration with community partners).

g) Clean Crop (Holyoke Start-up) engagement with STCC

A start-up based in Holyoke has sought to partner with the college on workforce development that would draw from a combination of fields/disciplines including photonics/optics, applied electrical engineering, and applied mechanical engineering. Dr. Cook also noted that Holyoke has some of the lowest energy rates in Massachusetts, which was a key reason for this company selecting the city.

h) November All-College Town Hall with Cabinet

Dr. Cook spoke about the upcoming All-College Town Hall meeting and shared that Cabinet members and himself will lead the Q&A. Also shared was that President Cook and CFO/Vice President of Administration Andrea Nathanson are members of the management team engaged in the next round of MCCC contract negotiations/bargaining, which is a state-wide process.

# IV. Chair's Report - Trustee Jynai McDonald, Chair Pro Tempore

- a) Acting Chair Jynai McDonald spoke about her experience at the 2023 Association of Community College Trustees (ACCT) Leadership Congress/Conference.
- **b**) The ACCT 2024 National Legislative Summit is being held in Washington D.C. in February 4-7, 2024 and noted that the Massachusetts Community College (MACC) is





highly represented at this summit. President Cook and Trustees attending have the opportunity to meet and have conversations with State legislators.

**c**) The DHE Statewide Trustee convening, originally scheduled on November 16, in Westborough MA has been cancelled.

Regarding Trustee appointments, Dr. Cook noted that the new Administration is working on re-establishing the Public Education Nominating Council (PENC).
