Call to Order

Trustee Christopher Johnson called the meeting to order at 5:08 p.m.

Tour of Health Science/Building 20

Trustee Christopher Johnson recessed at 5:10 p.m. to lead the Board of Trustees, staff and guests on a tour of Building 20, which houses the School of Health and Patient Simulation. Christopher Scott, Dean of the School of Health and Patient Simulation and his staff led the tour. An interactive, immersive opportunity to explore the fields of Surgical Technology, Respiratory Therapy, Medical Assisting, and Nursing. Board of Trustee members were engaged with a hands-on learning experience in SIMS Medical Center, the college nationally recognized patient simulation center to explore the roles of each of these healthcare fields of study. The Board

members experienced caring for realistic patients by assisting in performing a laparoscopic surgery, assisting in the removal of a sebaceous cyst, and helping to manage four patients in a hospital setting, including the management of a patient whose condition deteriorated while they were assisting in patient care. This tour highlighted the day to day learning environment for STCC health students.
