#### Due prior to the start of classes:

- ☐ **Tetanus, Diphtheria and Pertussis (TDaP)** vaccine administered within the past 10 years
- ☐ **Measles, Mumps, Rubella (MMR)** 2 dose vaccine series (or titer results showing immunity if no vaccine record)
- ☐ **Hepatitis B** 3-dose vaccine series (or 2-dose if HEPLISAV-B<sup>™</sup>) or positive surface antiBODY result
- ☐ **Varicella (chickenpox)** 2 dose vaccine series (or titer result showing immunity if no vaccine record)
- ☐ **Meningitis** For students age 21 and younger taking 12 credits or more, MenACWY(formerly MCV4) vaccine administered on/after 16<sup>th</sup> birthday OR <u>Meningitis Waiver</u> via <u>tinyurl.com/y6svra7b</u>

### Additional Requirements for those enrolling in Field Practicum (PSY-260):

## Due prior to registration:


□ **CORI Acknowledgement Form** – Bring valid identification to office or have form notarized and submit online. Form and instructions: **tinyurl.com/stcc-cori**. A new form is required annually in order to register for classes.

# Due prior to: July 1st for Fall practicum and December 1st for Spring

- ☐ **Technical Standards Acknowledgement Form** Complete the form at **tinyurl.com/y5c5cupv**
- ☐ Multiple Policies Acknowledgement Form Complete the form at tinyurl.com/y5xc4yu4
- ☐ Influenza Due by Oct. 1st for fall practicum and Dec. 1st for spring: one vaccine dose for the current flu season.

  Required documentation: Name, date of birth, date administered, manufacturer, LOT number and clinical site where administered or clinician name. Plan to provide this documentation to the field practicum site upon their request.
