Ms. Jennifer Murphy, Senior Property Manager, Springfield Technology Park, reported that the \$50,000 ARPA funding from the City of Springfield designated as Historical Preservation for brick repointing and window sealing, is conditional, and will require STCCAC to match funds spent. Possible improvement options were discussed for the ARPA and matching funds. She also reported that a recent meeting with the Lt. Governor of the Commonwealth was positive, and included recommendations on bond bills to pursue.

Ms. Shinéad Laventure, Assistant Controller, Appleton Corporation presented the Q 1 financial statements, which are included in the packet.

A motion was made by Mr. Daniel Keenan to accept the Q 1 of FY 24 Financial Statements. The motion was seconded by Ms. Ellen Freyman and approved unanimously via roll call.

Mr. Brendan Greeley, President, R.J. Greeley, Inc., shared leasing figures from the Tech Park for the calendar year 2023, including 17 total transactions, total square feet leased (around 40 K), total gross rent (\$10.5 M), retained annual gross rent (\$100 K) new annual gross rent (\$1 M) and number of employees working at the Tech park (275).
